# CONFORMAL QUATERNIONIC CONTACT CURVATURE AND THE LOCAL SPHERE THEOREM

#### Abstract

A curvature-type tensor invariant called quaternionic contact (qc) conformal curvature is defined on a qc manifolds in terms of the curvature and torsion of the Biquard connection. The discovered tensor is similar to the Weyl conformal curvature in Riemannian geometry and to the Chern-Moser invariant in CR geometry. It is shown that a qc manifold is locally qc conformal to the standard flat qc structure on the quaternionic Heisenberg group, or equivalently, to the standard 3-sasakian structure on the sphere if and only if the qc conformal curvature vanishes.

## 1. Introduction

A quaternionic contact (qc) structure introduced in [Biq1, Biq2] appears naturally as the conformal boundary at infinity of the quaternionic hyperbolic space. Such structures are also relevant for the quaternionic contact Yamabe problem which is naturally connected with the extremals and the best constant in an associated Sobolev-type embedding on the quaternionic Heisenberg group [IMV1, IMV2].

[^0]A qc structure on a real $(4 \mathrm{n}+3)$-dimensional manifold $M$ is a codimension three distribution $H$ locally given as the kernel of 1-form $\eta=\left(\eta_{1}, \eta_{2}, \eta_{3}\right)$ with values in $\mathbb{R}^{3}$ and the three 2 -forms $\left.d \eta_{i}\right|_{H}$ are the fundamental 2-forms of a quaternionic structure on $H$, i.e., there exists a Riemannian metric $g$ on $H$ and three local almost complex structures $I_{i}$ on $H$ satisfying the commutation relations of the imaginary quaternions, $I_{1} I_{2} I_{3}=-1$, such that, $\left.d \eta_{i}\right|_{H}=2 g\left(I_{i} .,.\right)$. The 1-form $\eta$ is determined up to a conformal factor and the action of $S O(3)$ on $\mathbb{R}^{3}$, and therefore $H$ is equipped with a conformal class $[g]$ of Riemannian metrics and a 2 -sphere bundle of almost complex structures, the quaternionic bundle $\mathbb{Q}$. The 2 -sphere bundle of one forms determines uniquely the associated metric and a conformal change of the metric is equivalent to a conformal change of the one forms. To every metric in the fixed conformal class one can associate a linear connection $\nabla$ preserving the qc structure, see [Biq1], which we shall call the Biquard connection.

The transformations preserving a given quaternionic contact structure $\eta$, i.e. $\bar{\eta}=\mu \Psi \eta$ for a positive smooth function $\mu$ and a $S O(3)$ matrix $\Psi$ with smooth functions as entries, are called quaternionic contact conformal (qc conformal for short) transformations.

Examples of QC manifolds are given in [Biq1, Biq2, IMV1, D1]. In particular, any totally umbilic hypersurface of a quaternionic Kähler or hyperKähler manifold carries such a structure [IMV1]. A basic example is provided by any 3-Sasakian manifold which can be defined as a ( $4 n+3$ )-dimensional Riemannian manifold whose Riemannian cone is a hyperKähler manifold. It was shown in [IMV1] that the torsion endomorphism of the Biquard connection is the obstruction for a given qc-structure to be locally 3 -Sasakian, up to a multiplication with a constant factor and a $S O(3)$-matrix.

The quaternionic Heisenberg group $\boldsymbol{G}(\mathbb{H})$ with its "standard" left-invariant qc structure is the unique (up to a $S O(3)$-action) example of a qc structure with flat Biquard connection [IMV1]. As a manifold $\boldsymbol{G}(\mathbb{H})=\mathbb{H}^{n} \times \operatorname{Im} \mathbb{H}$, while the group multiplication is given by

where $q, q_{o} \in \mathbb{H}^{n}$ and $\omega, \omega_{o} \in \operatorname{Im} \mathbb{H}$. The standard flat quaternionic contact structure is defined by the left-invariant quaternionic contact form $\tilde{\Theta}=\left(\tilde{\Theta}_{1}, \tilde{\Theta}_{2}, \tilde{\Theta}_{3}\right)=\frac{1}{2}\left(d \omega-q^{\prime} \cdot d \bar{q}^{\prime}+d q^{\prime} \cdot \bar{q}^{\prime}\right)$, where . denotes the quaternion multiplication.

The aim of this paper is to find a tensor invariant characterizing locally the qc structures which are quaternionic contact conformally equivalent to the flat qc-structure. With this goal in mind, we describe a curvature-type tensor $W^{q c}$ defined in terms of the curvature and torsion of the Biquard connection by (4.14), whose form is similar to the Weyl conformal curvature in Riemannian geometry (see e.g. [E]) and to the Chern-Moser invariant in CR geometry [ChM], see also [W]. We call $W^{q c}$ the quaternionic contact conformal curvature, qc conformal curvature for short. The main purpose of this article is to prove the following two facts.
Theorem 1.1. The qc conformal curvature $W^{q c}$ is invariant under quaternionic contact conformal transformations.

Theorem 1.2. A qc structure on a (4n+3)-dimensional smooth manifold is locally quaternionic contact conformal to the standard flat qc structure on the quaternionic Heisenberg group $\boldsymbol{G}(\mathbb{H})$ if and only if the qc conformal curvature vanishes, $W^{q c}=0$.

The quaternionic Cayley transform establishes a conformal quaternionic contact automorphism between the standard 3-Sasaki structure on the quaternionic sphere $S^{4 n+3}$ and the standard qc structure on $\boldsymbol{G}(\mathbb{H})$ [IMV1]. As a consequence of Theorem 1.2 and the fact that quaternionic Cayley transform is a quaternionic contact conformal equivalence between the 3 -sasakian structure on the sphere and the flat qc structure on $\boldsymbol{G}(\mathbb{H})$, we obtain
Corollary 1.3. A qc manifold is locally quaternionic contact conformal to the quaternionic sphere $S^{4 n+3}$ if and only if the qc conformal curvature vanishes, $W^{q c}=0$.

We note that for locally 3 -Sasakian manifolds a curvature invariant under quaternionic contact conformal transformations preserving the 3-Sasakian condition is defined in [AK] and it is shown that its vanishing is equivalent the structure to be locally isometric to the 3-Sasaki structure on the sphere.

Our investigations are close to the classical approach used by H.Weyl, see e.g. [E], while [ChM], [W] and [AK] followed the Cartan method of equivalence.

Organization of the paper. The paper relies heavily on the notion of Biquard connection introduced in [Biq1] and the properties of its torsion and curvature discovered in [IMV1]. In order to make the present paper self-contained, in Section 2 we give a review of the notion of a quaternionic contact structure and collect formulas and results from [Biq1] and [IMV1] that will be used in the subsequent sections.
Convention 1.4. We use the following conventions:
a) We shall use $X, Y, Z, U$ to denote horizontal vector fields, i.e. $X, Y, Z, U \in H$;
b) $\left\{e_{1}, \ldots, e_{4 n}\right\}$ denotes an orthonormal basis of the horizontal space $H$;
c) The summation convention over repeated vectors from the basis $\left\{e_{1}, \ldots, e_{4 n}\right\}$ will be used. For example, for a (0,4)-tensor $P$, the formula $k=P\left(e_{b}, e_{a}, e_{a}, e_{b}\right)$ means

d) The triple $(i, j, k)$ denotes any cyclic permutation of $(1,2,3)$. In particular, any equation involving $i, j, k$ holds for any such permutation.
e) $s$ and $t$ will be any numbers from the set $\{1,2,3\}, \quad s, t \in\{1,2,3\}$.
f) We shall denote with $\nabla h$ the horizontal gradient of the function $h$, while dh means as usual the differential of the function $h$, or the full gradient of $h$.

## 2. Quaternionic contact manifolds

In this section we will briefly review the basic notions of quaternionic contact geometry and recall some results from [Biq1] and [IMV1].

For the purposes of this paper, a quaternionic contact (QC) manifold $(M, g, \mathbb{Q})$ is a $4 n+3$ dimensional manifold $M$ with a codimension three distribution $H$ equipped with a metric $g$ and an $\operatorname{Sp}(\mathrm{n}) \mathrm{Sp}(1)$ structure, i.e., we have
i) a 2-sphere bundle $\mathbb{Q}$ over $M$ of almost complex structures $I_{s}: H \rightarrow H, \quad I_{s}^{2}=-1$, satisfying the commutation relations of the imaginary quaternions $I_{1} I_{2}=-I_{2} I_{1}=I_{3}$ and $\mathbb{Q}=\left\{a I_{1}+b I_{2}+c I_{3}: a^{2}+b^{2}+c^{2}=1\right\} ;$
ii) $H$ is locally the kernel of a 1 -form $\eta=\left(\eta_{1}, \eta_{2}, \eta_{3}\right)$ with values in $\mathbb{R}^{3}$ satisfying the compatibility condition $\quad 2 g\left(I_{s} X, Y\right)=d \eta_{s}(X, Y)$.
A QC manifold $(M, \bar{g}, \mathbb{Q})$ is called quaternionic contact conformal (qc-conformal for short) to $(M, g, \mathbb{Q})$ if $\bar{g} \in[g]$. In that case, if $\bar{\eta}$ is a corresponding associated one-form with complex structures $\bar{I}_{s}$, we have $\bar{\eta}=\mu \Psi \eta$ for some $\Psi \in S O(3)$ and a positive function $\mu$. In particular, starting with a QC manifold $(M, \eta)$ and defining $\bar{\eta}=\mu \eta$ we obtain a QC manifold ( $M, \bar{\eta}$ ) qc-conformal to the original one.

On a quaternionic contact manifold there exists a canonical connection defined in [Biq1] when the dimension $(4 n+3)>7$, and in [D] in the 7 -dimensional case.

Theorem 2.1. [Biq1] Let $(M, g, \mathbb{Q})$ be a quaternionic contact manifold of dimension $4 n+3>7$ and a fixed metric $g$ on $H$ in the conformal class $[g]$. Then there exists a unique connection $\nabla$ with torsion $T$ on $M^{4 n+3}$ and a unique supplementary subspace $V$ to $H$ in $T M$, such that:
i) $\nabla$ preserves the decomposition $H \oplus V$ and the $S p(n) S p(1)$-structure on $H, \nabla g=0, \nabla \mathbb{Q} \subset \mathbb{Q}$;
ii) for $X, Y \in H$, one has $T(X, Y)=-[X, Y]_{\mid V}$;
iii) for $\xi \in V$, the endomorphism $T(\xi, .)_{\mid H}$ of $H$ lies in $(s p(n) \oplus s p(1))^{\perp} \subset s o(4 n)$;

We shall call the above connection the Biquard connection. Biquard [Biq1] also described the supplementary subspace $V$, namely, locally $V$ is generated by vector fields $\left\{\xi_{1}, \xi_{2}, \xi_{3}\right\}$, such that

\left.\left.\left.\eta_{s}\left(\xi_{k}\right)=\delta_{s k}, \quad\left(\xi_{s}\right\lrcorner d \eta_{s}\right)_{\mid H}=0, \quad\left(\xi_{s}\right\lrcorner d \eta_{k}\right)_{\mid H}=-\left(\xi_{k}\right\lrcorner d \eta_{s}\right)_{\mid H} \tag{2.1}

The vector fields $\xi_{1}, \xi_{2}, \xi_{3}$ are called Reeb vector fields or fundamental vector fields.
If the dimension of $M$ is seven, the conditions (2.1) do not always hold. Duchemin shows in [D] that if we assume, in addition, the existence of Reeb vector fields as in (2.1), then Theorem 2.1 holds. Henceforth, by a qc structure in dimension 7 we shall mean a qc structure satisfying (2.1).

Notice that equations (2.1) are invariant under the natural $S O(3)$ action. Using the triple of Reeb vector fields we extend $g$ to a metric on $M$ by requiring $\operatorname{span}\left\{\xi_{1}, \xi_{2}, \xi_{3}\right\}=V \perp H$ and $g\left(\xi_{s}, \xi_{k}\right)=\delta_{s k}$. The extended metric does not depend on the action of $S O(3)$ on $V$, but it changes in an obvious manner if $\eta$ is multiplied by a conformal factor. Clearly, the Biquard connection preserves the extended metric on $T M, \nabla g=0$. We shall also extend the quternionic structure by setting $I_{s \mid V}=0$. The fundamental 2-forms $\omega_{s}$ of the quaternionic structure $Q$ are defined by

\left.2 \omega_{s \mid H}=d \eta_{s \mid H}, \quad \xi\right\lrcorner \omega_{s}=0, \quad \xi \in V \tag{2.2}
\end{equation*}
$$

Due to (2.2), the torsion restricted to $H$ has the form

$$
\begin{equation*}
T(X, Y)=-[X, Y]_{\mid V}=2 \omega_{1}(X, Y) \xi_{1}+2 \omega_{2}(X, Y) \xi_{2}+2 \omega_{3}(X, Y) \xi_{3} \tag{2.3}
\end{equation*}
$$

The properties of the Biquard connection are encoded in the properties of the torsion endomorphism $T_{\xi}=T(\xi,):. H \rightarrow H, \quad \xi \in V$. Recall that any endomorphism $\Psi$ of $H$ can be decomposed with respect to the quaternionic structure $(\mathbb{Q}, g)$ uniquely into $S p(n)$-invariant parts as follows $\Psi=\Psi^{+++}+\Psi^{+--}+\Psi^{-+-}+\Psi^{--+}, \quad$ where $\Psi^{+++}$commutes with all three $I_{i}, \Psi^{+--}$commutes with $I_{1}$ and anti-commutes with the others two and etc. The two $S p(n) S p(1)$-invariant components are given by

\begin{equation*}
\Psi_{[3]}=\Psi^{+++}, \quad \Psi_{[-1]}=\Psi^{+--}+\Psi^{-+-}+\Psi^{--+} \tag{2.4}
\end{equation*}
$$

Denoting the corresponding $(0,2)$ tensor via $g$ by the same letter one sees that the $S p(n) S p(1)$ invariant components are the projections on the eigenspaces of the Casimir operator

$$

\dagger=I_{1} \otimes I_{1}+I_{2} \otimes I_{2}+I_{3} \otimes I_{3} \tag{2.5}

corresponding, respectively, to the eigenvalues 3 and -1 , see [CSal]. If $n=1$ then the space of symmetric endomorphisms commuting with all $I_{i}, i=1,2,3$ is 1 -dimensional, i.e. the [3]-component of any symmetric endomorphism $\Psi$ on $H$ is proportional to the identity, $\Psi_{[3]}=\frac{|\Psi|^{2}}{4} I d_{\mid H}$.

Decomposing the endomorphism $T_{\xi} \in(s p(n)+s p(1))^{\perp}$ into symmetric part $T_{\xi}^{0}$ and skewsymmetric part $b_{\xi}, T_{\xi}=T_{\xi}^{0}+b_{\xi}$, we summarize the description of the torsion due to O. Biquard in the following Proposition.
Proposition 2.2. [Biq1] The torsion $T_{\xi}$ is completely trace-free,

\operatorname{tr} T_{\xi}=g\left(T_{\xi}\left(e_{a}\right), e_{a}\right)=0, \quad \operatorname{tr} T_{\xi} \circ I=g\left(T_{\xi}\left(e_{a}\right), I e_{a}\right)=0, \quad I \in Q
$$

The symmetric part of the torsion has the properties:

$$
T_{\xi_{s}}^{0} I_{s}=-I_{s} T_{\xi_{s}}^{0}, \quad I_{2} T_{\xi_{2}}^{0+--}=I_{1} T_{\xi_{1}}^{0-+-}, \quad I_{3} T_{\xi_{3}}^{0-+-}=I_{2} T_{\xi_{2}}^{0--+}, \quad I_{1} T_{\xi_{1}}^{0--+}=I_{3} T_{\xi_{3}}^{0+---}
$$

The skew-symmetric part can be represented as follows $b_{\xi_{s}}=I_{s} u$, where $u$ is a traceless symmetric (1,1)-tensor on $H$ which commutes with $I_{1}, I_{2}, I_{3}$.

If $n=1$ then $u$ vanishes identically, $u=0$ and the torsion is a symmetric tensor, $T_{\xi}=T_{\xi}^{0}$.
The $\operatorname{sp}(1)$-connection 1-forms are defined by $\nabla I_{i}=-\alpha_{j} \otimes I_{k}+\alpha_{k} \otimes I_{j}$, or equivalently determined with $\nabla \xi_{i}=-\alpha_{j} \otimes \xi_{k}+\alpha_{k} \otimes \xi_{j}$. The vanishing of the $\operatorname{sp}(1)$-connection 1-forms on $H$ is equivalent to the vanishing of the torsion endomorphism of the Biquard connection [IMV1].
2.1. The Ricci type tensors. Let $R=[\nabla, \nabla]-\nabla_{[,]}$be the curvature tensor of $\nabla$. We shall denote the curvature tensor of type $(0,4)$ by the same letter, $R(A, B, C, D):=g(R(A, B) C, D), A, B, C, D \in$ $\Gamma(T M)$. The Ricci tensor and the scalar curvature Scal of the Biquard connection, called qc-Ricci tensor and qc-sacalr curvature, respectively, are defined by

\operatorname{Ric}(X, Y)=R\left(e_{a}, X, Y, e_{a}\right), \quad S c a l=\operatorname{Ric}\left(e_{a}, e_{a}\right)=R\left(e_{b}, e_{a}, e_{a}, e_{b}\right)

The curvature of the Biquard connection admits also several horizontal traces, defined in [IMV1] by

The $s p(1)$-part of $R$ is determined by the Ricci 2 -forms by

\end{equation*}

According to [Biq1] the Ricci tensor restricted to $H$ is a symmetric tensor. If the trace-free part of the qc-Ricci tensor is zero we call the quaternionic structure a qc-Einstein manifold [IMV1]. It is shown in [IMV1] that the trace part of these Ricci type contractions is proportional to the qc-scalar curvature and the trace-free part of $\rho_{s}, \tau_{s}, \zeta_{s}$ vanish for exactly when the manifold is qc-Einstein (see also Theorem 2.4 below).

With the help of the operator $\dagger$ we introduced in [IMV1] two $S p(n) S p(1)$-invariant trace-free symmetric 2 -tensors $T^{0}, U$ on $H$ as follows

The tensor $T^{0}$ belongs to the [-1]-eigenspace while $U$ is in the [3]-eigenspace of the operator $\dagger$, i.e., they have the properties:

Applying Proposition 2.2 and equation (2.8), we obtain the following
Proposition 2.3. The torsion components of the symmetric part of torsion endomorphism of Biquard connection satisfy the relations

It is shown in [IMV1] that all horizontal Ricci type contractions of the curvature of the Biquard connection can be expressed in terms of the torsion of the Biquard connection. With slight modification based on Proposition 2.3 we collect some facts from [IMV1, Theorem 1.3, Theorem 3.12, Corollary 3.14 and Proposition 4.3] in the next

Theorem 2.4. [IMV1] On a $(4 n+3)$-dimensional $Q C$ manifold, $n>1$ mthe next formulas hold

For $n=1$ the above formulas hold with $U=0$.

In particular, the qc-Einstein condition is equivalent to the vanishing of the torsion endomorphism of the Biquard connection. If Scal $\neq 0$ the latter holds exactly when the qc-structure is 3-sasakian up to a multiplication by a constant and an $S O(3)$-matrix with smooth entries.

We derive from [[IMV1], Theorem 4.8]

2.2. Quaternionic Heisenberg group and the quaternionic Cayley transform. Since our goal is to classify quaternionic contact manifolds locally conformal to the quaternionic Heisenberg group we recall briefly its definition together with the definition of the quaternionic Cayley transform as described in [IMV1, Section 5.2]. As a manifold the quaternionic Heisenberg group of topological dimension $4 n+3$ is $\boldsymbol{G}(\mathbb{H})=\mathbb{H}^{n} \times \operatorname{Im} \mathbb{H}$. The group law is given by $\left(q^{\prime}, \omega^{\prime}\right)=\left(q_{o}, \omega_{o}\right) \circ(q, \omega)=$ $\left(q_{o}+q, \omega+\omega_{o}+2 \operatorname{Im} q_{o} \bar{q}\right)$, where $q, q_{o} \in \mathbb{H}^{n}$ and $\omega, \omega_{o} \in \operatorname{Im} \mathbb{H}$. We can identify the group $\boldsymbol{G}(\mathbb{H})$ with the boundary $\Sigma$ of a Siegel domain in $\mathbb{H}^{n} \times \mathbb{H}, \Sigma=\left\{\left(q^{\prime}, p^{\prime}\right) \in \mathbb{H}^{n} \times \mathbb{H}: \Re p^{\prime}=\left|q^{\prime}\right|^{2}\right\}$. The Siegel domain $\Sigma$ carries a natural group structure and the map $(q, \omega) \mapsto\left(q,|q|^{2}-\omega\right) \in \Sigma$ is an isomorphism between $\boldsymbol{G}(\mathbb{H})$ and $\Sigma$.

On the group $\boldsymbol{G}(\mathbb{H})$, the standard contact form, written as a purely imaginary quaternion valued form, is given by $2 \tilde{\Theta}=(d \omega-q \cdot d \bar{q}+d q \cdot \bar{q}), \quad$ where $\cdot$ denotes the quaternion multiplication,

Since $\quad d p=q \cdot d \bar{q}+d q \cdot \bar{q}-d \omega, \quad$ under the identification of $\boldsymbol{G}(\mathbb{H})$ with $\Sigma$ we also have $2 \tilde{\Theta}=-d p^{\prime}+2 d q^{\prime} \cdot \bar{q}^{\prime}$.

The left invariant flat connection on $\boldsymbol{G}(\mathbb{H})$ coincidies with the Biquard connection of the qc manifold $(\boldsymbol{G}(\mathbb{H}), \tilde{\Theta})$ and, conversely, any qc manifold with flat Biquard connection is locally isomorphic to $\boldsymbol{G}(\mathbb{H})$ [IMV1].

The Cayley transform is the map $\mathcal{C}: S \mapsto \Sigma$ from the sphere $S=\left\{|q|^{2}+|p|^{2}=1\right\} \subset \mathbb{H}^{n} \times \mathbb{H}$ minus a point to the Heisenberg group $\Sigma$, with $\mathcal{C}$ defined by

The unit sphere $S$ carries a natural qc structure $\tilde{\eta}=d q \cdot \bar{q}+d p \cdot \bar{p}-q \cdot d \bar{q}-p \cdot d \bar{p}$ which has zero torsion and is 3-Sasakian up to a constant factor. In [IMV1] it was noted that the Cayley transform is a quaternionic contact conformal diffeomorphism between the quaternionic Heisenberg group with its standard quaternionic contact structure $\tilde{\Theta}$ and $S \backslash\{(-1,0)\}$ with the structure $\tilde{\eta}$

## 3. Curvature and the Bianchi identities

Recall that an orthonormal frame

is a qc-normal frame (at a point) if the connection 1-forms of the Biquard connection vanish (at that point). Lemma 4.5 in [IMV1] asserts that a qc-normal frame exists at each point of a QC manifold.

In general, to verify any $S p(n) S p(1)$-invariant tensor identity at a point it is sufficient to check it in a qc-normal frame at that point. Further, we work in a qc-normal frame.

Let $b(A, B, C)$ denote the Bianchi projector,

Proposition 3.2. A QC manifold is locally isomorphic to the quaternionic Heisenberg group exactly when the curvature of the Biquard connection restricted to $H$ vanishes, $R_{\left.\right|_{H}}=0$.

Proof. Taking into account [IMV1, Proposition 4.11], in order to see the claim it is sufficient to show that the (full) curvature tensor vanishes. From $R_{\left.\right|_{H}}=0$ we can conclude, cf. [IMV1, Proposition 4.2, Proposition 4.3, Theorem 4.9], that the vertical distribution $V$ is involutive and

## 4. Quaternionic contact conformal curvature. Proof of Theorem 1.1

In this section we define the quaternionic contact conformal curvature and prove Theorem 1.1.
4.1. Conformal transformations. A conformal quaternionic contact transformation between two quaternionic contact manifold is a diffeomorphism $\Phi$ which satisfies $\Phi^{*} \eta=\mu \Psi \cdot \eta$ for some positive smooth function $\mu$ and some matrix $\Psi \in S O(3)$ with smooth functions as entries, where $\eta=$ $\left(\eta_{1}, \eta_{2}, \eta_{3}\right)^{t}$ is considered as an element of $\mathbb{R}^{3}$. The Biquard connection does not change under rotations, i.e., the Biquard connection of $\Psi \cdot \eta$ and $\eta$ coincides. Hence, studying qc conformal transformations we may consider only transformations $\Phi^{*} \eta=\mu \eta$.

We recall the formulas for the conformal change of the corresponding Biquard connections from [IMV1]. Let $h$ be a positive smooth function on a QC manifold ( $M, \eta$ ). Let $\bar{\eta}=\frac{1}{2 h} \eta$ be a conformal deformation of the QC structure $\eta$. We will denote the objects related to $\bar{\eta}$ by over-lining the same object corresponding to $\eta$. Thus, $d \bar{\eta}=-\frac{1}{2 h^{2}} d h \wedge \eta+\frac{1}{2 h} d \eta, \bar{g}=\frac{1}{2 h} g$.

The new triple $\left\{\bar{\xi}_{1}, \bar{\xi}_{2}, \bar{\xi}_{3}\right\}$, determined by the conditions (2.1) defining the Reeb vector fields, is $\bar{\xi}_{s}=2 h \xi_{s}+I_{s} \nabla h$. The horizontal sub-Laplacian and the norm of the horizontal gradient are defined respectively by $\triangle h=\operatorname{tr}_{H}^{g}(\nabla d h)=\nabla d h\left(e_{\alpha}, e_{\alpha}\right),|\nabla h|^{2}=d h\left(e_{\alpha}\right) d h\left(e_{\alpha}\right)$. The Biquard connections $\nabla$ and $\nabla$ are connected by a $(1,2)$ tensor S ,

4.3. Proof of Theorem 1.1. The relevance of $W R$ is partially justified by the following Theorem.

Theorem 4.4. The tensor $W R$ is invariant under qc conformal transformations, i.e. if

After a careful study of the structure of the equation we put the output in the following form

## 5. Converse problem. Proof of Theorem 1.2

Suppose $W^{q c}=0$, hence $W R=0$ by Proposition 4.2. In order to prove Theorem 1.2 we search for a conformal factor such that after a conformal transformation using this factor the new qc structure has Biquard connection which is flat when restricted to the common horizontal space $H$. After we achieve this task we can invoke Proposition 3.2 and conclude that the given structure is locally qc conformally flat. With this considerations in mind, it is then sufficient to find (locally) a solution $h$ of equation (4.21) with $M_{[s y m]}=-L$. In fact, a substitution of (4.21) in (4.15) and an application of the condition $W^{q c}=0=W R$ allows us to see that the qc structure $\bar{\eta}=\frac{1}{2 h} \eta$ has flat Biquard connection.

Let us consider the following overdetermined system of partial differential equations with respect to an unknown function $u$

The proof of Theorem 1.2 will be achieved by considering all possible cases of (5.6). It will be presented as a sequel of subsections, which occupy the rest of this section. Let us remind that the goal is to show that the vanishing of the qc conformal tensor $W^{q c}$ implies the validity of (5.6) which guaranties the existence of a local smooth solution to the system (5.1)-(5.5).
5.1. Case 1, $A, B, C \in H$. Integrability condition (5.9).

When we consider equation (5.6) on $H$ it takes the form

The other integrability condition in this case, (5.97), can be obtained similarly using (5.66) and the Ricci identities.

The proof of Theorem 1.1 is complete.
